Critically important to the Foundation, our educators and supporters, the program will contain an impact barometer to solicit feedback, measure results and help us refine the efficacy of program content.

Campus Assemblies, Scalable from 100 students in a classroom or library setting to 5,000 or more in an arena venue, the Tribute to Valor team has presented to over 40,000 students from its inception in 2018 through early 2020 when the outbreak of Covid-19 prohibited direct engagement. Once schools are back to campus learning, the Tribute to Valor team will be ready to resume our Campus Assembly programs. An impactful example of the scope of Tribute to Valor was reflected in our program delivered to 10,000 students in the Killeen Independent School dist at the Bell County Exposition Center on Nov 4-5, 2019. Two 75 minute assemblies were conducted to an audience of 5,000 at each presentation.

The Lt Colonel James Megellas/Cornelius Feenstra Scholarship World War II Veteran Lt. Colonel Megellas was the most decorated officer in the history of the famed 82nd Airborne division. He led the crossing of the Waal River during Operation Market Garden, and on May 2nd 1945, he would liberate a conc camp. The Wobbelin Conc Camp was a starvation camp for political prisoner, Jews and enemies of the Nazi regime. The camp was located near the town of Lügwallust Germany and at its height held 5000 prisoners, incl Mr. Cornelius Feenstra. On May 2nd, 1945, Lt. Col Megellas and members of the 82nd liberated the camp saving the lives of many, to include Mr. Feenstra. Fast forward nearly 75 years and on Mar 10th 2020 through the Tribute to Valor Foundation, Mr. Feenstra was reunited with Lt. Col Megellas at a special celebration. The Megellas/Feenstra Scholarship is presented in honor of Lt. Colonel Megellas and Cornelius Feenstra whose life was saved when the camp was liberated 75 years ago.
